Minutes of the Circle Relaxation Committee (CRC) meeting held on 31.05.2021 to consider cases of deceased Government Servant for appointment on compassionate grounds against vacancies for the year 2019 in Group 'C' Cadre.

The Meeting of Circle Relaxation Committee consisting of following officers was held on 31.05.2021 to consider and examine the cases for appointment on compassionate grounds in relaxation to normal Recruitment Rules, of employees of the Department who died while in service.

2. The following is the vacancy position in different Cadres in Group-C, arrived @ 5% of the total vacancies under Direct Recruitment Quota, meant for Compassionate Appointment for the year 2019 (01.01.2019 to 31.12.2019). The CRC has considered the cases of compassionate appointment limited to the extent of vacancies earmarked.

4. The consolidated instructions of DoP&T dated 16.01.2013 prescribes for eligibility of applicants seeking compassionate appointment. The applicant should be

However, it also provides for certain relaxations described hereunder:-

- a) Upper age limit can be relaxed wherever found to be necessary. The lower age limit should however, in no case be relaxed below 18 years of age.
- b) In exceptional circumstances Govt. may consider recruiting persons not immediately meeting the minimum educational standard. Govt. may engage them as trainees who will be given the regular pay bands and grade pay only on acquiring the minimum qualification prescribed under the recruitment rules. The emoluments of these trainees, during the period of their training and before they are absorbed in the Government as employees, will be governed by the minimum of the IS Pay Band (Pre-revised) of Rs.4440-7440 without any Grade Pay. In addition, they will be granted all applicable allowances. The same shall be calculated on the minimum –IS pay band without any grade pay. The period spent in the -IS pay band by the future recruits will not be counted as service for any purpose as their regular service will start only after they are placed in the pay band of PB-I Rs.5200-20200 along with grade pay of Rs.1800.
- c) In case of appointment of a widow not fulfilling the requirement of educational qualification, against the post of Multi-Tasking Staff, she will be placed in Group 'C' Pay Band-I (Rs.5200-20200) + Grade Pay Rs.1800/- directly without insisting on fulfillment of educational norms, in view of DoP&T OM No. 14014/2/2009-Estt(D) dated 03.04.2012 and DoP&T OM No. 14014/02/2012-Estt (D) dated 16.01.2013.
- 5. The ruling contained in the following judgments were also kept in view while considering the cases of compassionate appointment.
- (i) The Hon'ble Apex Court in its judgment dated April 8, 1993 in the case of Auditor General of India and others vs. G. Ananta Rajeswara Rao has held that appointment on grounds of descent clearly violates Article 16(2) of the Constitution but if the appointment is confined to the son of daughter or widow of the Government servant who died in harness and who needs immediate appointment on grounds of immediate need of assistance in the event of there being no other earning member in the family to

supplement the loss of income from the bread winner to relieve the economic distress of the members of the family, it is unexceptionable.

(ii) The Hon'ble Supreme Court's in its judgment dated May 4, 1994 in Umesh Kumar Nagpal case has laid down following important principles.

Only dependents of an employee dying in harness leaving his family in penury and without any means of livelihood can be appointed on compassionate grounds.

b) The whole object of granting compassionate appointment is to enable the family to tide over the sudden crisis and to relieve the family of the deceased from financial destitution and to help it get over the emergency.

Offering compassionate appointment as a matter of course irrespective of the financial condition of the family of the deceased or medically retired Government servant is legally impermissible.

d) Compassionate Appointment cannot be granted after lapse of reasonable period and it is not vested right which can be exercised at any time in future.

- (iii) Hon'ble CAT, Jabalpur Bench in OA No. 708 of 2008 in the matter titled as Kamlesh Trivedi vs. Union of India & others in its judgment dated 17.03.2009 held that "The family not found to be in penury conditions and there were more indigent person than the applicant. Thus the Tribunal would not be justified to reverse these findings recorded after complete appreciation of factual aspect."
- (iv) Hon'ble CAT, Ahmadabad Bench in OA No. 179 of 2009 in the matter of Shri Brijesh Kumar D. Patel vs. Union of India & Others vide judgment dated 19.04.2010 held that "When subsequent to the death of the bread earner, sufficient time has passed and bereaved family has maintained themselves, there can be no direction to the competent authority to consider the claim for compassionate appointment. This is a factual finding and the Tribunal will not enter into merits of the same because whether the deceased left the family in penury without any means of livelihood has to be decided by the competent authority and the courts can not normally interfere. Compassionate appointment cannot be claimed by way of right or as heritable public office."
- (v) In the case of HSEB vs. Krishna Devi it was held by the Hon'ble Appex Court that Compassionate appointment cannot be claimed as a matter of right against guidelines prescribed by the government.

The following cases have been reconsidered by the CRC in pursuance to orders passed by Hon'ble CAT, Chandigarh Bench.

7. Against the 5% Direct Recruitment Quota vacancies earmarked for the year 2019 as mentioned in Para-2 above, total 42 cases as per Annexure-I have been considered by CRC for P.A/S.A, Postman/MailGuard and MTS Cadre as per indigent condition and required educational qualification.

- 8. Based on the criteria as laid down in Directorate letter no. 17-4/2018-SPG.II dated 28.09.2020, the Relative Merit Points were allocated for 10 attributes. 15 Bonus points were added wherever widow/wife applied for compassionate appointment. Allocation of points and total number of points of each applicant are given in consolidated list (Annexure-I). Based on this consolidated list, the candidates have been recommended on merit basis as per indigent points and their educational qualification subject to availability of vacancies under compassionate appointment quota.
- 9. The degree of indigence of each applicant in comparison to other cases received for consideration is arrived by the Circle Relaxation Committee taking into account all the relevant factors and various attributes, subject to fulfillment of eligibility conditions as per instructions contained in DOPT OM No. F.14014/02/2012-Estt(D) dated 16.01.2013, 30.05.2013 and 05.09.2016. The Member of CRC have considered all the compassionate appointment cases and recommended 05 cases for P.A/S.A Cadre, 03 cases for P.M/M.G and 05 cases for MTS Cadre for compassionate appointment against the vacancies earmarked for compassionate appointment quota, strictly in order of merit arrived as per indigent points and the eligibility criteria prescribed for education qualification as detailed in Annexure-B.
- Four belated cases and one earning member case as per details given in 10. Annexure-C are examined by the members of the CRC to check the feasibility of consideration in accordance with the instructions and guidelines issued by DoP&T and circulated by Postal Directorate. These cases are more than 09 years old. The members of the Committee observed that these cases are too old and in case like Ms. Somita, D/o Late Sh. Joginder Singh Ex. S.A 'LD' Division Ludhiana and Sh. Karandeep S/o Late Sh. Charan Singh, Ex-Postman Ludhiana City Division is having other source of income/earning member in the family of the deceased employee. The mother of both the applicants are a serving ladies and have been leading their family as an additional support. Therefore, the applicants cannot be regarded as a wholly dependent, as per Note-I below, para 2 of Scheme for compassionate appointment. Since the family has survived so many years from the date of death of the deceased and these cases no more fall in the category of indigent cases. The members of the Committee further observed that the concept of compassionate appointment is largely related to the need for immediate assistance to the family of the deceased to relieve from economic hardship. The very fact that the family has been able to manage somehow, all these years is taken as adequate proof that family had some dependable means of subsistence. Therefore, Committee reject these cases for appointment on compassionate grounds in view of the facts detailed in Para 5 above.
- 11. The applicants mentioned at Sr. no. 4, 5, 7, 11 & 17 of Annexure-I have 81, 81, 72, 59 & 50 points. The CRC recommends these cases for appointment on compassionate ground with relaxation in upper age, in view of Para no. 6 B(a) of the Scheme for compassionate appointment issued vide DoPT OM No. 14014/02/2012-Estt(D) dated 16.01.2013.
- 12. The cases mentioned in <u>Annexure-D</u> were considered & found them to be not so indigent & deserving in comparison to the cases which are recommended. The cases are not recommended only in view of non-availability of vacancies in Group-C cadre in view of 5% ceiling of Direct Recruitment vacancy (ies).
