I am directed to refer a copy of Directorate letter No Vig-01/1/2021-Vigilance-DOP dated 26/11/2021 and 31-1/2021-PO dated 23/12/2021 on the subject noted above for information, guidance & strict compliance.

The instructions on the subject has already been issued vide this office letter of even No dated 02/12/2021. All are requested to ensure that all the employees are sensitized not to insist on the name and address of the sender and accept the envelopes marked as 'PIDPI' or 'Public Interest Disclosure and Protection of Informer' addressed to the CVC by entering 'PIDPI' in the name and address fields of Registered/ Speed Post articles. It is also requested to spread awareness by displaying the informative posters (Copy enclosed) at the prominent places in all the Post Offices both in English and regional languages as well as in the BOs and smaller officers, the posters should be printed on A-4 size paper and displayed on the notice board.

The status report is required to be sent to Directorate. All are, therefore, requested to submit status report by 05/01/2022.

This relates to the need for awareness creation about the mechanism of "Complaint under the Public Interest Disclosure and Protection of Informer" (PIDPI) introduced by the Central Vigilance Commission (CVC). In this regard, kindly refer the letter of even no dated 03/03/2021, 03/11/2021 of this Division and subsequent letter No. Vig-01/1/2021-Vig. dated 26.11.2021 of Vigilance Division wherein instructions of Central Vigilance Commission in the matter were conveyed to all Circles for adherence.

- 2. It was conveyed therewith that any article / envelope super-scribed with "Complaint under the Public Interest Disclosure and Protection of Informer" (PIDPI)" and addressed to CVC or CVO must be accepted at the counter of post offices without insisting on the sender's address. In such cases, the phrase/ term PIDPI can to be entered in the space /portion meant for name and address of sender while booking of the Regd. / Speed Post articles.
- 3. It was also requested to display the posters (copy of illustrative sample enclosed) meant for awareness-creation about this mechanism at prominent places in post offices. Additionally, in Branch Post Offices and smaller offices the posters should be printed on A-4 size (or any other appropriate size) paper and displayed on the notice board.
- 4. It has since been reported that these instructions are not being followed and citizens who wish to bring forward any complaint within the "PIDPI" ambit are still being asked to provide their name and address in many post offices defeating the purpose of said instructions. Lack of for the above. The CVC has expressed its concern to the Department in this regard. Hence, the aforesaid requirement w.r.t PIDPI part needs to be implemented in letter and spirit at the post offices.

Sir/ Madam,

I am directed to refer to the CVC D.O. letter No. Conf/Misc/21/02 dated 17.11.2021 and PO Division office letter No. 31-01/2021-PO dated 03.03.2021 and 03.11.2021 (copies enclosed) whereby instructions regarding acceptance of the envelopes addressed to CVC and marked as 'PIDPI' or 'Public Interest Disclosure and Protection of Informer' without insisting on the name and address of the sender were issued to all the Heads of Circles.

- 2. It has been observed that the aforesaid instructions have not percolated down to all those who are involved in the booking of Registered/ Speed Post articles. In this regard, concerns have been raised by the Central Vigilance Commission citing the gap in the implementation of the aforesaid instructions.
- 3. It is, therefore, reiterated that all the employees may be sensitized not to insist on the name and address of the sender and accept the envelopes marked as 'PIDPI' or 'Public Interest Disclosure and Protection of Informer' addressed to the CVC by entering 'PIDPI' in the name and address fields of Registered /Speed Post articles. It is also requested to display the poster (copy enclosed) at prominent places in Post Offices under your jurisdiction. It is suggested that in the BOs and smaller offices, the posters should be printed on A-4 size paper and displayed on the notice boards. It is also requested to give wide publicity to these instructions duly translated in local/ regional languages through the use of Circle websites and other social media platforms. PTCs may also be instructed to include these in the different training modules.
- 4. The matter may be accorded 'Top Priority'.


Only complaints against Central Government officials (including PSBs, PSUs and UTs) can be accepted

Your name and address <u>should</u>, however, be written on the complaint letter inside so that confirmation can be sought by the office of the Commission
