2. The promotion is subject to the following terms and conditions:

- In case any vigilance/Disc. case of the type referred to in OM No. 22011/2/86-Estt.(A) dated 12-1-88 from DOPT circulated vide DG Posts New Delhi Memo No. 25-19/88-SPG dated 4.5.88 subsequently revised vide DOP &T Memo No. 22022/4/91-Estt (A) dated 14.9.92 circulated vide DG Posts New Delhi Memo No. 25-19/88-SPG dated 13.10.92 is pending against the official, he should not be relieved for posting without obtaining specific orders from this office. In case the official against whom any punishment is current he should not be posted before expiry of punishment and case be reported to this office immediately.
- Where in respect of any of the official, some punishment like withholding of increment, etc. is current, he should not be posted / relieved and his case should be reported to this office immediately.
- The Divisional Head Concerned should communicate these promotion orders to the official(s) concerned immediately. As per Directorate letter no W-18/2/2022-SPN-1 dated 15.07.22. Divisional Heads are required to seek acceptance or refusal of the promoted official in a day or two of the receipt of this memorandum and forward it to this office at the end of 2nd day in a consolidated manner.

- v) Acceptance of the official includes the acceptance of the place of posting and representation for change of posting will be entertained only on joining at new post. The representation for change of the place of posting etc. before accepting the offer will be treated as "deemed refusal" and liable to usual embargo.
- vi) No fresh offer of appointment in LSG (P) cadre shall be made to the official(s) who refuse the promotion in LSG (P) Cadre for a period of one year / till a next vacancy arises, whichever is later, vide DG P&T No. 22011/5/86-Estt. dated 10.4.89.
3. In terms of D.G Posts New Delhi OM No. 4-7/(MACPS)/2009-PCC dated 18.09.2009 further circulated vide letter No. Estt/15-1/2009/Corr dated 12.10.2009, in case of refusal of promotion by any employee before becoming entitlement to financial upgradation under the MACP scheme, no financial upgradation shall be allowed, as the employee has not been stagnated due to lack of opportunities. If, however, financial upgradation has been allowed due to stagnation and the employee(s) subsequently refuse the promotion, it shall not be a ground to withdraw the financial upgradation. He/she shall, however, not be eligible to be considered for further financial upgradation till he agrees to be considered for promotion again and in such cases, the second or the next financial upgradation shall also be deferred to the extent of period of debarment due to the refusal of promotion.
4. No leave of any kind should be granted to any official who is to be relieved under these orders. The official who has been transferred / posted, if proceeded on leave on MC after issue of these orders shall be deemed to have been relieved and shall not be allowed to rejoin their present posts without specific permission of this office.
5. Factual discrepancy, if any, may be brought to the notice of this office at once.
6. In accordance with DOPT OM no. 36012/45/2005-Estt (Res) dated 10.08.2010, further clarified vide Directorate letter no. 137/15/2014-SPN-II dated 19.03.2019, circulated vide letter no. STA/18-31/R/III dated 26.03.2019; the promotion will remain subject to the outcome of SLP(C) no. 30621/2011 (Jarnail Singh & Ors Vs Lachhmi Narain Gupta & Ors) and SLP(C) No. 31288/2017 and any other court case(s) in connected matter.
7. In case the official wish to choose the date of fixation of pay under FR-22 (I) (a) (1) he can do so within one month from the date of assumption of charge.
