Dear Candidate,

Based on the results of Combined Higher Secondary Level Examination (CHSLE), 2019 and allocation of the candidates to the Circle vide Directorate letter No. W-04/7/2022-SPN-I dated 26.08.2022 your name has been declared by Staff Selection Commission (SSC) for appointment as Sorting Assistant in RMS Divisions; Postal Assistant in Post Offices / Circle Office/ Region Office/ Saving Bank Control Organization of Punjab Circle in Department of Posts in Level-4 in the Pay Matrix of 7th CPC.

- 2. A candidate will be allocated to one of the 13 Postal Divisions, 02 RMS Divisions, Saving Bank Control Organization in the Punjab Circle and Circle Office/ Regional office Chandigarh for appointment as Postal Assistant/Sorting Assistant. Allocation of Postal Division/ Units (i.e Circle Office/Region Office/ Saving Bank Control Organization) will be made as per the following criteria:
- (a) A candidate shall be allocated to a Postal/RMS Division/ units (i.e Circle Office/Region Office/ Saving Bank Control Organization) on the basis of her / his merit (rank) in CHSLE 2019, order of preference (option), and vacancy available in a Postal/RMS/Units (i.e Circle Office/Region Office/ Saving Bank Control Organization) at her/his turn in the category she / he has been selected.
- (b) Person with benchmarks disability (PwBD) candidates irrespective of their ranks will be allocated Postal/RMS/ Units (i.e Circle Office/Region Office/ Saving Bank Control Organization) in the manner indicated at (a) first followed by Ex-serviceman candidates.
- (c) After allocation of Divisions to PwBD candidates and Ex-serviceman candidates, remaining candidates will be allocated Postal /RMS/Units(i.e Circle Office/Region Office/Saving Bank Control Organization) in the manner mentioned in (a)above.
- (d) All such candidates who do not give any order of preference or are not allocated to any of the Postal/RMS/ Units (i.e Circle Office/Region Office/ Saving Bank Control Organization) mentioned in their limited preferences, shall be allocated to nearby Postal/RMS/ Units subject to availability of vacancy in the category she / he has been selected, after allocation of Postal /RMS/ Units (i.e Circle Office/Region Office/ Saving Bank Control Organization) to all other candidates.
- 3. The Postal/RMS Divisions/ Units (i.e Circle Office/Region Office/ Saving Bank Control Organization) wise and category-wise vacancies are detailed as under. The candidates who will not give their order of preference or indicate their preference only for a few Postal/RMS/ Units will be at a disadvantage, as mentioned at para 2(d) above; therefore, it is advised to give order of preference for all the 17 Postal /RMS/Units (i.e Circle Office/Region Office/ Saving Bank Control Organization) mentioned.
