Sub: Declaration of result in connection with CE-2022 for recruitment to the cadre of Postman, Mail Guard from eligible GDSs against vacancies for the year 2022 including against unfilled vacancies of SCF-2022 & LDCE-2022.

The Chief Postmaster General, Punjab Circle, Chandigarh is pleased to declare result of CE-2022 for recruitment to the cadre of Postman, Mail Guard from eligible GDSs against vacancies for the year 2022 including against unfilled vacancies of SCF-2022 & LDCE-2022. The CE -2022 was held on 04.09.2022 & DEST held on 01.10.2022.

2. Instructions contained in Para 8 & 9 of Directorate letter envisage as under:-

"Stage-VIII:- After completion of Stage-VII, if still some vacancies are left, those will be added to the vacancies earmarked for GDS candidates to arrive at the total vacancies available for GDS candidates.

Stage-IX (Parent Division list of GDS Candidates for vacancies of Postman / Mail Guard):- Publication of Division-wise list of successful GDS candidates (merit list), out of the qualified GDS candidates of the recruiting Division, for the posts of Postman and Mail Guard, equal to the number of vacancies in each category. Process of appointment to the selected post / refusal of offer of appointment, similar to the process at Stage-II to Stage-IV above will be repeated till all the vacancies of Recruiting Division are exhausted nor qualified GDS candidates of Recruiting Division are not available for appointment."

2.1 Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022, indicating criteria of selection, is as under:-

- Performance in both Paper-I and Paper-II (combined, i.e. total of marks secured in Paper-I and Paper-II) will be considered for selection to the posts of Postman / Mail Guard, provided a candidate has qualified in both Paper-III & Paper-IV.
- Merit list will be prepared only on the basis of total marks secured in Paper-I and Paper-II. After arranging the candidates in order of merit, number of candidates to be declared successful shall be equal to the number of vacancies in each category.

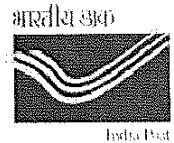

6. **Instruction for joining process of candidates.**

All Head of Units of selected candidates are instructed to take necessary action for joining of newly selected candidates as per extant provisions.

Any mistake in the name of candidate, Roll number, Community etc. may be brought to the notice of this office immediately and necessary corrections may be made at your end.

Divisional heads are requested to verify suitability of PwD candidate, if any, in accordance with Dte letter No.12-10/2017-SCT dated 24.04.2019 before issue of appointment order.

The caste/tribe certificate of the promoted official, if belonging to SC/ST category may be verified and it may also be ensured that caste/tribe certificate of the official, if belong to SC/ST is still figuring in the notified central list of Scheduled Caste/Tribe before actually giving him/her promotion.

7. **Instruction for candidates who decline the offer.**

If any candidate is unwilling to accept offer, he/she should submit his/her unwillingness to the head of Parent Division in **prescribed** Performa (enclosed) on 19.10.2022, failing which it shall be termed as "deemed declination". Divisional Head should send the copy of unwillingness of such candidates in one lot by 19.10.2022.

8. In case, subsequently if it is found that any of the qualified candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other reasons or in case, any mistake is found with regard to announcement of the result of any candidates for any reason whatsoever, his/her name will be deleted from the list of successful candidate, as the case may be. The result is also subject to any change in merit list of the selected candidates due to any unforeseen reasons in accordance with the existing rules on the subject.

9. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & the verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit. In case any vigilance/ Disciplinary case is pending against any of the officials, he/she should not be relieved for posting without obtaining specific orders from this office.
