Sub: Declaration of result in connection with LDCE for promotion to the posts of Postman and Mail Guard from eligible Multi-Tasking Staff officials for the vacancy year 2022 (01.01.2022 to 31.12.2022) held on 04.09.2022 & DEST held on 01.10.2022.

The Chief Postmaster General, Punjab Circle, Chandigarh is pleased to declare result of LDCE for promotion to the posts of Postman and Mail Guard from eligible Multi-Tasking Staff officials for the vacancy year 2022 (01.01.2022 to 31.12.2022) held on 04.09.2022 & DEST held on 01.10.2022.

2. Instructions contained in Para B of Directorate letter no. 17-08/2018-SPN-I dated 15.06.2022, prescribes as under:-

"Stage-I (Parent Division list of MTS candidates for vacancies of Postman / Mail Guard):- Publication of Division-wise list of successful MTS candidates (merit list), out of the qualified MTS candidates of the recruiting Division, for the posts of Postman and Mail Guard, equal to the number of vacancies in each category....."

2.1 Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022, prescribes as under:-

- Performance in both Paper-I and Paper-II (combined, i.e. total of marks secured in Paper-I and Paper-II) will be considered for selection to the posts of Postman / Mail Guard, provided a candidate has qualified in both Paper-III & Paper-IV.
- Merit list will be prepared only on the basis of total marks secured in Paper-I and Paper-II. After arranging the candidates in order of merit, number of candidates to be declared successful shall be equal to the number of vacancies in each category.

3. Division-wise list of selected candidates in order of merit is attached as Annexure-I.

4. 11 Backlog Vacancies of PwD Category were offered to MTS Candidates of PwD Category in the examination but none MTS candidate of PwD category appeared in examination. Due to non-availability of PwD candidates, these vacancies were offered to person other than a person with benchmark disability (i.e. MTS candidates) in view of Para 8.1 & 8.2 of DoPT letter no. 36035/02/2017-Estt (Res) dated 15.01.2018.

5. Further, due to non-availability of qualified MTS Candidates, 148 unfilled vacancies shall be added to vacancy earmarked for GDS as per relevant clause of Recruitment Rules, 2020.

7. Final Answer key of Paper I and Paper II is attached as Annexure-III.

8. Instruction for joining process of candidates.

All Head of Units of selected candidates are instructed to take necessary action for joining of newly selected candidates as per extant provisions.

Any mistake in the name of candidate, Roll number, Community etc. may be brought to the notice of this office immediately and necessary corrections may be made at your end.

The caste/tribe certificate of the promoted official, if belonging to SC/ST category may be verified and it may also be ensured that caste/tribe certificate of the official, if belong to SC/ST is still figuring in the notified central list of Scheduled Caste/Tribe before actually giving him/her promotion.


9. Instruction for candidates who decline promotion.

If any candidate is unwilling to accept promotion, he/she should submit his/her unwillingness to the head of Parent Division in **prescribed** Performa (enclosed) on 12.10.2022, failing which it shall be termed as "deemed declination". Divisional Head should send the copy of unwillingness of such candidates in one lot by 12.10.2022.

10. In case, subsequently if it is found that any of the qualified candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other reasons or in case, any mistake is found with regard to announcement of the result of any candidates for any reason whatsoever, his/her name will be deleted from the list of successful candidate, as the case may be. The result is also subject to any change in merit list of the selected candidates due to any unforeseen reasons in accordance with the existing rules on the subject.

11. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & the verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit. In case any vigilance/ Disciplinary case is pending against any of the officials, he/she should not be relieved for posting without obtaining specific orders from this office.
