Sub:

Allotment of surplus qualified candidates to deficit Postal Divisions/Units in connection with CE-2022 for recruitment to the cadre of Postman, Mail Guard from eligible GDSs against vacancies for the year 2022.

The Chief Postmaster General, Punjab Circle, Chandigarh is pleased to allot surplus qualified candidates to deficit Postal Divisions/Units in connection with CE-2022 for recruitment to the cadre of Postman, Mail Guard from eligible GDSs against vacancies for the year 2022. The CE -2022 was held on 04.09.2022 & DEST held on 01.10.2022.

Instructions contained in Para 12 & 13 of Directorate letter dated 15.06.2022 envisage as under:-

"Stage-XI (For vacancies of Postman / Mail Guard earmarked for GDS):- After completion of process at Stage-XA, the process at Stage-X will be repeated till all the vacancies of Postal Division earmarked for GDS are exhausted or qualified GDS candidates of Postal Division are not available for appointment to the posts of Postman.

Stage-XII (If vacancies of Postman / Mail Guard earmarked for GDS are still available):- Publication of Surplus list of successful GDS candidates (merit list) from all RMS Divisions for the posts of Postman indicating the allocated Postal Division, as per preference exercised, equal to the number of unfilled vacancies, category-wise, earmarked for GDS in each Postal Division.

Similarly, Surplus list of successful GDS candidates (merit list) from all Postal Divisions for the posts of Mail Guard indicating the allocated RMS Division, as per preference exercised, equal to the number of unfilled vacancies, category-wise, earmarked for GDS in each RMS Division shall be published."

- 2.1 Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022, indicating criteria of selection, is as under:-
- a) Performance in both Paper-I and Paper-II (combined, i.e. total of marks secured in Paper-I and Paper-II) will be considered for selection to the posts of Postman / Mail Guard, provided a candidate has qualified in both Paper-III & Paper-IV.
- b) Merit list will be prepared only on the basis of total marks secured in Paper-I and Paper-II. After arranging the candidates in order of merit, number of candidates to be declared successful shall be equal to the number of vacancies in each category.

- 3. List of selected surplus qualified candidates in order of merit viz-a-viz preferences exercised by them is attached as Annexure-I.
- 4. Abstract of Vacancies notified, filled and unfilled is attached as Annexure II.
- Instruction for joining process of candidates.

All Head of Units of selected candidates are instructed to take necessary action for joining of newly selected candidates as per extant provisions.

Any mistake in the name of candidate, Roll number, Community etc. may be brought to the notice of this office immediately and necessary corrections may be made at your end.

Divisional heads are requested to verify suitability of PwD candidate, if any, in accordance with Dte letter No.I2-10/2017-SCT dated 24.04.2019 before issue of appointment order.

The caste/tribe certificate of the selected candidate, if belonging to SC/ST/OBC category may be verified and it may also be ensured that caste/tribe certificate of the official, if belong to SC/ST/OBC is still figuring in the notified central list of Scheduled Caste/Tribe/Other Backward Class before actually giving him/her appointment.

7. Instruction for candidates who accept/decline the offer.

If any candidate is willing / unwilling to accept offer, he/she should submit his/her willingness/ unwillingness to the head of Parent Division in prescribed Performa (enclosed) on or before 09.11.2022, failing which it shall be termed as "deemed declination". Divisional Head should send the copy of willingness/unwillingness of such candidates in one lot by 09.11.2022.

- 8. In case, subsequently if it is found that any of the qualified candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other reasons or in case, any mistake is found with regard to announcement of the result of any candidates for any reason whatsoever, his/her name will be deleted from the list of successful candidate, as the case may be. The result is also subject to any change in merit list of the selected candidates due to any unforeseen reasons in accordance with the existing rules on the subject.
- 9. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & the verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit. In case any vigilance/ Disciplinary case is pending against any of the officials, he/she should not be relieved for posting without obtaining specific orders from this office.
