Sub:

Declaration of allotment of surplus qualified candidates to deficit Divisions/Unit/Administrative Offices in connection with CE-2022 for recruitment to the cadre of MTS from eligible GDSs against vacancies for the year 2022 (01.01.2022 to 31.12.2022).

The Chief Postmaster General, Punjab Circle, Chandigarh is pleased to allot surplus qualified candidates to deficit Divisions/Units/Administrative Offices in connection with CE-2022 for recruitment to the cadre of MTS from eligible GDSs against vacancies for the year 2022 (01.01.2022 to 31.12.2022).

2. Instructions contained in Para 13 of Directorate letter dated 15.06.2022 envisage as under:-

"Stage-XIII (Surplus List of GDS candidates for the post of MTS):- After completion of the process at Stage-XA, if vacancies of MTS are available in any Division / Unit / Administrative offices, surplus list of successful GDS candidates (merit list) from all Divisions/Units for the posts of MTS indicating the allocated Division / Unit / Administrative Office, as per preference exercised, equal to the number of unfilled vacancies, category-wise, earmarked for GDS in each of the Division / Unit / Administrative Office shall be published. Process of appointment to the selected post / refusal of offer of appointment, similar to the process at Stage-II shall be followed with the modification that acceptance of offer of appointment within 7 days will be sufficient and the candidates may be allowed to join within further fifteen days. This process will be repeated till vacancies of MTS are exhausted or qualified GDS candidates are not available for appointment, whichever is earlier."

- 2.1 Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022, indicating criteria of selection, is as under:-
- a) Performance in Paper-I only will be considered for selection to the post of MTS & Paper-III is qualifying only.

- 4. Surplus list of GDS candidates selected in order of merit viz-a-viz preferences exercised by the candidate for the post of MTS (Both in Administrative Offices & Subordinate Offices) is attached as Annexure-I.
- 5. Abstract of Vacancies notified, filled and unfilled is attached as Annexure II.

6. Instruction for joining process of candidates.

All Head of Units of selected candidates are instructed to take necessary action for joining of newly selected candidates as per extant provisions.

Any mistake in the name of candidate, Roll number, Community etc. may be brought to the notice of this office immediately and necessary corrections may be made at your end.

Divisional heads are requested to verify suitability of PwD candidate, if any, in accordance with Dte letter No.l2-10/2017-SCT dated 24.04.2019 before issue of appointment order.

The caste/tribe certificate of the selected candidate, if belonging to SC/ST/OBC category may be verified and it may also be ensured.that caste/tribe certificate of the official, if belong to SC/ST/OBC is still figuring in the notified central list of Scheduled Caste/Tribe/Other Backward Class before actually giving him/her appointment.

7. Instruction for candidates who accept/decline the offer.

If any candidate is willing / unwilling to accept offer, he/she should submit his/her willingness/ unwillingness to the head of Parent Division in prescribed Performa (enclosed) on or before 10.11.2022, failing which it shall be termed as "deemed declination". Divisional Head should send the copy of willingness/unwillingness of such candidates in one lot by 10.11.2022.

- 8. In case, subsequently if it is found that any of the qualified candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other reasons or in case, any mistake is found with regard to announcement of the result of any candidates for any reason whatsoever, his/her name will be deleted from the list of successful candidate, as the case may be. The result is also subject to any change in merit list of the selected candidates due to any unforeseen reasons in accordance with the existing rules on the subject.
- 9. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & the verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit. In case any vigilance/ Disciplinary case is pending against any of the officials, he/she should not be relieved for posting without obtaining specific orders from this office.


