The Chief Postmaster General, Punjab Circle, Chandigarh is pleased to declare result of CE for recruitment to the posts of MTS from eligible GDS Candidates for the vacancy year 2025 (01.01.2025 to 31.12.2025) held on 31.08.2025.

2. Instructions contained in Para G of Directorate letter no. 17-08/2018-SPN-I dated 18.10.2023 read with letter dated 31.10.2023, prescribes as under:-

**Stage – VI (List of GDS Candidates for the post of MTS):-** List of Successful GDS candidates (Merit list) for the posts of MTS, equal to number of vacancies in each category, shall be published. Process of appointment to the selected post/ refusal of offer of appointment, similar to the process at Stage-II and III above will be repeated. This process will be repeated till all the vacancies are exhausted or qualified GDS candidates are not available for appointment.

2.1 Directorate letter no. 17-08/2018-SPN-I dated 05.04.2022, indicating criteria of selection, envisage that performance in Paper-I only will be considered for selection to the post of MTS. Directorate letter no. 17-08/2018-SPN-I dated 10.07.2024 has reviewed the syllabus and pattern of Examination and it has been decided that component of Local Language test (Paper-III) for the post of MTS shall be dispensed with.

2.2 Minimum Qualifying Marks

Category	Qualifying criteria	Paper-I + Paper-II
OC	40%	37.6 (Out of 94 marks)
OBC/EWS	37%	34.78 (Out of 94 marks)
SC/ST/PwBD	33%	31.02 (Out of 94 marks)

2.3 In those cases where two or more candidates get clubbed due to securing equal marks, their inter-se rank/merit has been decided in the following order:-

- Inter-se rank/merit will be decided as per date of birth where the older candidate will be placed higher than the younger candidate for all categories including GDS candidates.
- In respect of GDS candidate, if date of birth is also same, the person who is senior in the common seniority / gradation list of GDS will be placed higher and if there is no common seniority/ gradation list than the GDS who was engaged earlier on continuous basis shall be placed higher in the rank/merit.

3. The list of selected candidates in accordance with the merit viz-a-viz preferences exercised viz-a-viz availability of vacancy in respective Division is enclosed as **Annexure-I**.

6. **Instruction for joining process of candidates.**

All Head of Units of selected candidates are instructed to take necessary action for joining of newly selected candidates as per extant provisions. Any mistake in the name of candidate, Roll number, Community etc. may be brought to the notice of this office immediately and necessary corrections may be made at your end.

Divisional Heads are requested to verify suitability of PwBD candidate, if any, in accordance with Dte letter No.12-10/2017-SCT dated 24.04.2019 before issue of appointment order.

The caste/tribe certificate of the GDS, if belonging to SC/ST/OBC category may be verified and it may also be ensured that caste/tribe certificate of the official, if belong to SC/ST/OBC is still figuring in the notified central list of Scheduled Caste/Tribe before actually giving him/her appointment orders.

In case of appointment against vacancies reserved for OBC, a clause in the offer of appointment would be inserted to the effect that appointment will be provisional and subject to

verification of the community certificate, in accordance with DOPT OM No. 36033/4/97-Estt.(Res.) dated 25.07.2023.

*"The appointment is provisional and is subject to the community certificate being verified through the proper channels. If the verification reveals that the claim of the candidate belong to Other Backward Classes or not to belong to creamy layer is false, his/her service will be terminated forthwith without assigning any further reasons and without prejudice to such further action as may be taken under the provisions of Bharatiya Nyaya Sanhita(BNS) for production of false certificates".*

Persons who are not covered under the scheme of reservation of SCs, STs and OBCs and who's family has gross annual income as prescribed, are to identified as EWS for the benefit of reservation, in accordance with Directorate letter no. 17-09/2019-GDS dated 26.02.2019. Divisional Heads are requested to verify certificates of EWS candidates before issue of appointment orders.

#### 7. Instruction for candidates who decline offer of appointment.

If any candidate is willing/unwilling to accept offer, he/she should submit his/her willingness/unwillingness to the head of Parent Division in **prescribed** proforma (enclosed) by 20.01.2026, failing which it shall be termed as "deemed declination". Divisional Head should send the copy of unwillingness of such candidates in one lot by 20.01.2026.


8. In case, subsequently if it is found that any of the qualified candidate(s) was not eligible to appear in the examination under the extant rules or instructions on the subject or for any other reasons or in case, any mistake is found with regard to announcement of the result of any candidates for any reason whatsoever, his/her name will be deleted from the list of successful candidate, as the case may be. The result is also subject to any change in merit list of the selected candidates due to any unforeseen reasons in accordance with the existing rules on the subject.

9. The selection of the candidates is purely provisional subject to the fulfillment of required conditions of relevant Recruitment Rules & the verification of genuineness of various mandatory certificates of the candidates by the concerned head of the unit. Before relieving an official to join post of MTS, Divisional Head shall follow the guidelines issued vide Directorate letter no. 17-47/2024-GDS dated 14.10.2024.

10. It is enjoined upon all concerned that appointment orders shall be issued by 20.01.2026 positively.
